RULES

- Any coach with more than one team in the tournament MUST have an alternate coach for either team due to possible scheduling conflicts. Games will not be scheduled around coach's conflicts.
- Participants may play on ONE team only during the tournament, regardless of age group. No exceptions!
- Age group is determined by the OLDEST member on a team. Players may play up in age group, but not down. No exceptions!
- All age groups will use the High School Federation Rules as a basis.
- Recreational division should consist of teams that are "league assigned" or beginners. This division is more for fun. No pressing will be allowed, except for the LAST 2 MINUTES of the game .
- Competitive division should consist of teams that are traveling teams or select teams. This division is for teams that are more advanced and have played in competitive leagues in the past. Will play by MSHSAA rules.
- Each team is responsible for providing one scorekeeper/timekeeper for each game. A parent is fine for this.

SPECIAL RULES FOR 2ND / 3RD GRADE

- Teams in the 2nd and 3rd grade divisions will be required to play man-to-man defense at all times, even on out-of-bounds plays. No zone.
- Pressing will not be allowed in the 3rd grade division except for the last 2 minutes of the game.

GAME LENGTH

- All games will use a running clock with the following exceptions: The clock will stop for all free throws, timeouts, injuries and any other time deemed necessary by the official. In addition, the clock will stop for all normal violations the last 2 minutes of the second half.
- Running Clock: If at any time during the game the point differential is 20 or more points, a running clock will be used.
- Grades 2, 3, 4, 5 & 6 will play 16 minute halves. Overtime is 2 minutes. Clock will stop for normal violations.
- Grades 7, 8 & 9 will play 18 minute halves. Overtime is 2 minutes. Clock will stop for normal violations

TIME-OUTS

- Teams are allowed 3 full timeouts per game. Timeouts will not carry over to overtime. One timeout allowed in overtime.

BALL SIZE

- All 2nd, 3rd, 4th, 5th & 6th Grade divisions. as well as all girls teams will use a 28.5" ball. 7th, 8th & 9th Grade boys divisions will use the full size ball. All teams must furnish their own balls for warm-up and games.
